Changes Ahead

The first half of 2021 has brought many changes to our office. Planning is in full swing for our 4th grade field days this year and we hope to have the event "as normal" this year. We know there were a lot of disappointed students last year when we had to cancel due to the pandemic.

June brought some staffing changes to the district and our Program Coordinator, Kristen was promoted to Conservation Director. We thank Sina for almost seven years of service and wish her luck in her future endeavors. We are in the process of hiring a new Program Coordinator.

We have finished our Lake and River Enhancement Grant (LARE) which allowed us to complete a diagnostic study of the Walnut Fork-Sugar Creek watershed. We are about halfway through our Clean Water Indiana (CWI) grant, which allowed us to hire Kristen last year. She has been on board for almost eight months now and is bringing lots of content to our website and social media channels as well as organizing events, including our new CISMA (see the next article for an update!). Kristen recently graduated from the Indiana Watershed Leadership Academy and collaborated with Jasper and Pike SWCDs to produce a video highlighting producers involved in conservation practices throughout the state, including Montgomery County's very own Zach Cain! CISMA Update

We are charging ahead with our Cooperative Invasive Species Management Area (CISMA) and have been networking with local organizations and citizens to remove invasive species from the county. We were awarded a grant from the Southern Indiana Cooperative Invasives Management (SICIM) in February that will allow us to host multiple events along the Sugar Creek Trail in collaboration with the Crawfordsville Parks Department.

In mid-April, we partnered with NICHES Land Trust to host our "call-out" meeting. Instead of having a zoom meeting call-out to introduce our CISMA creation to the public, we decided it would be more productive (and more fun!) to have a workday event. We had four three-hour shifts over two days to remove invasive Garlic Mustard from Bachner Nature Preserve. Bachner is one of two Montgomery County properties owned by NICHES.

We held our first "Weed Wrangle" with Parks in May to remove Wintercreeper at the River Rock Trailhead. Weed Wrangles are volunteer events hosted nationwide to control invasive plants that are negatively impacting our public parks, green spaces, and natural areas. Keep an eye out for more of these events on of Facebook page and website! We will be returning to each site for multiple years to ensure invasive species are kept under control.
