
## Introducing our New Program Coordinator!

### **River Friendly Farmer Award Given to** Cains Farms Inc.

We are very excited to announce that Cains Farms Inc. has been awarded IASWCD's River Friendly Farmer Award for 2021! This statewide award program started in 1999 to recognize farmers who help keep Indiana's rivers, lakes, and streams clean through good management practices.

Zach Cain accepted the award on behalf of Cains Farms Inc. at the Indiana State Fair on August 18th. Cains Farms Inc. produces corn and soybeans along with some wheat. They have installed several filter strips to prevent surface water run off from entering waterways. Practicing no-till has benefitted their land during large rain events as the water infiltrates at a higher rate. Approximately 100 acres of their land was put into the Conservation Reserve Program (CRP) with several acres specifically focused on protecting quail and pheasant habitat. They contribute greatly to the district's education efforts by hosting 4th grade field days every year. We appreciate the great things they do for the district and for the environment!
