Dave- NRCS in field finishing waterways from last year. 1/2 Brown township to do. EQIP 6 are in. Grazing lands in and 2 high tunnels, 2 more in waiting. Heather is learning ropes, good job.

Adam- Heather Conners is in 6th week. She is good; computer, talking on phone, explaining programs and for the northern part of county has connections. General signups are ongoing. Can reenroll total field grasses. General CRP bidding process list in June are ranked from Washington DC. However, those continuing are a local decision. Chemically burn and replant for quail v pheasants require shorter grass and different seed producers. Now more maintenance is required for quail. Year 3 and 4 plant sunflowers and LET OFFICE KNOW. Next week 6 people for 3 days from head office are coming for file reviews and in field practices. Producers need signed waiver to allow some practices. Tracking paper is important. Montgomery County has the 1/3 most CRP contracts in USA. Stark County has more acres. 3400-page map is to be printed and in mail end April or 1st May. Can be marked and drop off v sitting in office. PARP Program is not easy to understand. Compare revenue from 18 or 19 to 20, to show loss in 2020. Shall be digitally submitted and then signed on pad. One done so far. We do not know what % the payouts will be if any. Farmers.gov. Tax returns after subtracted out non- eligible are used. Need a 20% loss unless otherwise qualified.

County Council- will have several upcoming meetings on salaries.

Extension- AG Days are coming up. 2019 was the last year for them. Dave and Kristen are speaking. Classes are on diversify garden and diet. Food sampling will occur. Details on Facebook. Check web site for upcoming events. She has demand for soil tests.

The committee was established in 2017 and has planted 23 trees. Jordan 1st \$2000 leveraged by CMS if possible, 2nd Raoul.
